I, Daniel Jem, (Falsely Accused), a real Man and Natural person, not a TITLE or Trust, am an American of We the People for the United States of America as represented by the Constitution for the United States of America and the Bill of Rights of 1787; At all times by special appearance and not by general visitation, conferring no jurisdiction whatsoever, whether appearing in person or in writing, am challenging the in-personam Jurisdiction of all Officers, Judges, and Representatives of this Court, the City, the County and the State, at all times forever, until Just and Lawful Jurisdiction is proved to me with written documentation on the basis of satisfactory evidence according to the Constitution of Justice for We the People of the United States of America, and whether appearing in person or in writing, am preserving and demanding all of my rights at all times forever and waiving none of my rights at any time, including, but not limited to, my right to travel to and fro upon the public roadways while upholding the Rights of other travelers, and do, by these presents, I give you,

Notice of Foreign Law, making a **Claim of Status** that I am not a resident of the State of Utah, (Utah Corporation) and am not a citizen of United States Corporation; Stating and claiming that Utah Corporation and the United States Corporation are a Foreign Jurisdiction to Utah State republic and the Constitution for the United States of America republic of We the People; And, by these presents I give you:

Refusal for Cause Without Dishonor, refused instrument numbered: **C12MANYFRAUD**, for cause without dishonor based on the clear Jurisdictional absence.

Notice: The causes for which said instrument is refused are as follows:

1. I, Daniel Jem, am a real Man and natural person; the NAME on the accusation C12MANYFRAUD, is not my Name; it is a NAME created by UTAH Corporation, and by such is not a Lawful Notice. I am not under any Lawful contract with the STATE OF UTAH (Utah Corporation), for the purpose of Driving; I was not engaged in Commerce and was not Driving. I do not Drive and have not had any Contract with the STATE OF UTAH for the purpose of Driving for many years, and even before this; Any Contract that I signed was under coercion and duress without full Disclosure. I give my allegiance to Justice and Human Rights = the Constitution of Justice = the Supreme Law of the Nation and Planet Earth.
2. I am falsely accused of committing a Violation: Driving without a Driver License; while exercising my Natural and Constitutional Right to traveling upon the Public roadway upholding the Rights of other travelers, I did not violated a person's Rights, I did not caused any harm or damage to other travelers and I did not violate their Rights. The exercising of Rights and upholding Rights is not a violation upon rule of Law or Rights and is not a crime; Crime is a violation upon Rights; causing harm or damage upon other people, it is not a violation upon crime, lawlessness, robbery, terrorism, and treason. Rules that violate Rights are not rule of law; they are the double standard of lawlessness and treason, Rights are not crimes, rule of Law is not financial and spiritual robbery and murder; Justice is Rights and Rights are rule of Law upholding the people's Rights and this is Justice: All Sacred Truth and Proper Order. That which violates Rights, does not constitute rule of law. A Right is not Privilege that requires a License, the only requirement to have the Right to travel on the public roadways in control of an automobile, is Certification of competency, of age, ability and commitment to uphold the Rights of other travelers.

“Personal Rights largely consist of the Right of locomotion -- to go where and when one pleases—only so far restrained as the Rights of others may make it necessary for the welfare of all other citizens. The Right to travel upon the public roadways and to transport property thereon, by reasonable means or automobile, is not a mere privilege which may be permitted or prohibited at will, but the common Right which people have under their Right to life, liberty, and the pursuit of justice. Under this Constitutional guarantee, one may therefore, under normal conditions, travel at their inclination upon the public roadways or in public places, and while conducting their self in an orderly and decent manner, neither interfering with nor violating a person's Rights, he will be protected, not only in person, but in safe conduct.”

3. “All laws which are repugnant to the Constitution are null and void.” Marbury vs. Madison, 5 US (2 Branch) 137, 174, 176, (1803)

“When rights secured by the Constitution are involved, there can be no rule making or legislation which would abrogate them.” Miranda vs. Arizona, 384 US 436 p. 491.

“An unconstitutional act is not law; it confers no rights; it imposes no duties; affords no protection; it creates no office; it is in legal contemplation, as inoperative as though it had never been passed.” Norton vs. Shelby County 118 US 425 p. 442

“The Law is: an unconstitutional statute, though having the form and name of law, is in reality no law, but is wholly void, and ineffective for any purpose; since unconstitutionality dates from the time of its enactment, and not merely from the date of the decision so branding it.

“No one is bound to obey an unconstitutional law and Courts are not bound to enforce it.” 16 Am Jur 2nd, 177 late 2d, Sec 256

4. Said instrument has been rightfully refused for cause by this instant instrument, in Administrative Review, for these numbered Causes, therefore said instrument has no lawful force or effect and your instrument numbered: **C12MANYFRAUD** is void on its face and without affect.

Demand:

At your own prerogative, you may choose to honor and uphold my Natural and Constitutional Rights. However;

1. Where, your instrument numbered: C12MANYFRAUD, was rightfully refused for the Causes shown without dishonor;
2. Therefore, I demand that you discharge your instrument of having any relation with me by:
 - a) taking no further action, in which case your tacit admission to this instant instrument's Causes shown will be accepted as complete discharge of your attempted allegations; or by,
 - b) presenting Notice to me that you have so discharged your instrument and any alleged underlying causes.
 - c) I demand that all unlawful actions and accusations cease and desist immediately.

In either case you must inform any other parties you have involved with your instrument of your actions or you may be subject to significant civil and/or criminal damages.

Caveat:

Your instrument and any alleged underlying causes of action are herewith barred by the Doctrine of Justice, Constitutional Supreme Law = Rule of Law = Human Rights.

US CODE > TITLE 18 > PART I > CHAPTER 13 > 241

241. Conspiracy against rights

If two or more persons conspire to injure, oppress, threaten, or intimidate any person in any State, Territory, Commonwealth, Possession, or District in the free exercise or enjoyment of any right secured to him by the Constitution or laws of the United States, or because of his having so exercised the same; or if two or more persons go in disguise on the highway, or on the premises of another, with intent to prevent or hinder his free exercise or enjoyment of any right so secured [by this Constitutional Jurisdiction] They shall be fined under this title or imprisoned not more than ten years, or both; and if death results from the acts committed in violation of this section or if such acts include kidnapping or an attempt to kidnap, aggravated sexual abuse, or an attempt to commit aggravated sexual abuse, or an attempt to kill, they shall be fined under this title or imprisoned for any term of years or for life, or both, or may be sentenced to death.

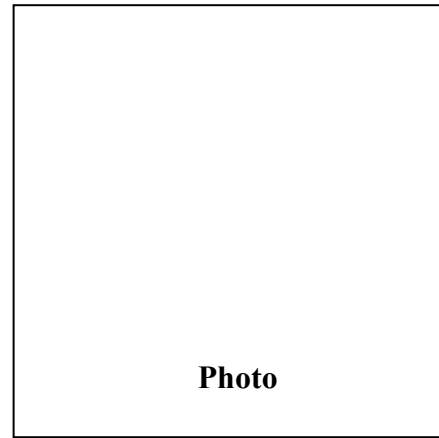

Notice of Request to Be Informed

(of all information requested by My Notice sent by Certified Mail on March 9, 2017 to all presiding Representatives, Officers, Judges and Attorneys supporting the accusations against Me)

I, Daniel Jem, do hereby; request written Notice of your action upon this instrument, by mailed to my mailing address; whether you choose to discharge your instrument and any alleged underlying causes, or for any reason maintain or make an accusation upon me.

If, for any reason, you choose to maintain or make an accusation upon me, then by these presents, I request to be informed with written documentation of all the following nature and cause of the accusation; so that I will be informed and able to find competent and qualified assistance of counsel for my Defense of all my rights opposing the accusation, so that I will be able to proceed defending all my rights!

1. Who is accusing me and by what Supreme Law and Authority am I being accused?
2. Within which Constitutional Jurisdiction am I being accused?
3. For what purpose and cause am I being accused and for what reason?
4. Who am I being accused of causing damage upon and what is the alleged cost of such damage?
5. What is, if any, the Constitutional in-personam Jurisdiction of this Court, City, County, and State?
6. What is the nature and purpose of this Court: the Judges, Officers, and Representatives?

I request clarification of the nature of the accusation and this Court considering the jurisdictional implications of the accusation, there are three options:

- A. 'Is this court a Martial Law Court?', or,
 - B. 'Is this court an Admiralty Court?', or,
 - C. 'Is this court a Common Law Court?'.
1. If this Court is a Martial Law Court this Accused must be apprised that the constitutionally secured Justice given natural rights have been suspended under some Lawful Order and this Accused must have been apprised of the nature of the Court for this Court to establish jurisdiction, and this Accused has not been so apprised so this Court has no right to jurisdiction and any orders from this Court are void having no effect on this Accused; Therefore this Accused demands that the Judges, Officers, and Representatives of this Court exonerate this Accused of any and all charges and sentences.
 2. If this Court is an Admiralty Court the Accused must be under some kind of international Contract to be obligated to the jurisdiction of this Court, and this Accused is not aware of any such Contract, and without proof that such a contract exist, this Court has no right to in personam jurisdiction and any orders from this Court are void ab initio having no effect on this Accused; Therefore this Accused demands that the Judges, Officers, and Representatives of this Court exonerate this Accused of any and all charges and sentences.
 3. If this Court is a Common Law Court this Accused must have entered into a Contract knowingly, voluntarily, and intentionally, making void my Common Law, constitutionally secured Justice given natural rights, and this Accused is not aware of any such Contract, and without proof that such a Contract exist, this Court has no right to in-personam jurisdiction and any orders from this Court are ab initio having no effect on this Accused; Therefore this Accused demands that the Judges, Officers, and Representatives of this Court exonerate this Accused of any and all charges and sentences, and by these presents,

I give, my request hereby that conforms to my right to be informed of the nature and cause of the accusation and my right to have compulsory process to have qualified assistance of counsel for my defense, that conforms to the **Constitution for the United States of America, Amendment VI. Notice of Noncontradictory Definitions of Rights, Law, and Justice:

Rights are not a manmade invention. All rights come from serving and upholding the Natural and Common Laws and principles of Justice which include upholding Human Rights which include the right to serve and be served by honest and fair Common Law Contracts that are entered into knowingly, intentionally, and voluntarily without being forced, coerced, suppressed or deceived. Rights do not come from counterfeit governments and they do not come from your neighbors, they come from upholding the rights of your neighbors that are based on the natural and common laws and principles of Justice. Rights do not come from the whims of wealthy and Powerful people. A right is the Power and Liberty to exercise individual freedom and authority in harmony with the Laws of Justice and Human Rights. Rights are what is right in the honest and true Jurisdiction, rights = meaning that which is necessary to maintain and improve the long-term quality of life on this planet for those who are accountable to the Natural Laws that make life possible and that maintain and improve the long-term quality of life, the Natural, eternal, and Common Laws of Justice. With respect to the meaning of the word (rights) and with respect to Rule of Law, I saw the use of the word (law) in a Citation that I was given; for any word or law to have any true valid meaning or authority or significant value, that word or law must have a consistent and unchanging meaning and value, and must be consistently and equally applied and must be consistent with the Supreme and Natural laws of Justice that govern life, the constitution of Justice; the word “Justice” meaning the most efficient and highest quality of life for those who are accountable to the Natural Laws that are necessary to create the greatest and best quality of life, meaning, that the reward or punishment must fit and equal the value of the act or action. The only people who receive real privilege from Government are the evil traitors at the top of the Evil hierarchy of Fraud; all other so-called privileges are nothing more than counterfeit, pure fraud, deception, and robbery!
