(These Notices Constitute My Appearance) May 14, 2019

I, the living spirit and man, Daniel Jem, (Falsely Accused), am a United States American of We the People secured by the Constitution for the United States of America and the Bill of Rights of 1787; with lawful Oath of Allegiance; At all times by special appearance and not by general visitation, conferring no jurisdiction whatsoever, whether appearing in person or in writing, am challenging the in-personam Jurisdiction of all Officers, Judges, and Representatives of this Court, the City, the County and the State, at all times forever, until Just and Lawful Jurisdiction is proved to me with written documentation on the basis of Lawful evidence according to the Constitution of Justice for We the People of the United States of America, and whether appearing in person or in writing, am preserving and holding all of my rights at all times forever and waiving none of my rights at any time, including, but not limited to, my right to travel to and fro upon the public roadways while upholding the Rights of other travelers; **“ The claim and exercise of a constitutional Right cannot be converted into a crime” Miller vs. U.S., 230F. 486, 489 ;** And do, by these presents, I give you, **Notice of Status and Foreign Law**, stating that I am not a citizen of the STATE OF UTAH, (Utah Corporation) and am not a Citizen of United States Corporation; Stating and claiming that Utah Corporation and the United States Corporation are a Foreign Jurisdiction to Utah State republic and the Constitution for the United States of America, the Natural Living Republic of We the People.

If You Representatives of the State of Utah and in Iron County Justice Court; can not prove you have in-personam Jurisdiction within the **Constitution for the United States of America, including the Bill of Rights of 1787** and all Natural Rights that are self-evident in the Rule of the Law of Rights and Justice; and that are referenced in **Amendment IX in the Bill of Rights**, then I, Daniel Jem, **Request**, that this Accusation be dismissed for lack of Just Cause; for acting in honor and respect with no harm caused; to do Justice in this instance; and if anyone working for the STATE OF UTAH Corporation or Utah State, does contradict any of these Facts in Evidence; then I, Daniel , **Request**, an original Copy of His/Her Statement signed under penalty of perjury and with a copy of their Constitutional Oath, to be mailed to me at the correct mailing address on the **Certificate of Service**,

And by these presents, I give you: **Judicial Notice of Facts**

I, the Living Spirit and Man, Daniel Jem, have rescinded and revoked my Signature on the day of signing the NOTICE OF: TRIAL dated: April 23, 2019 that I signed under duress and Coercion, not being of clear mind as a result of 24 days of unlawful imprisonment and arrest, in violation of my Natural and Constitutionally secured Right to Due Process of Law; My Right to be fully informed of the Nature of the Accusation; that was not upheld as demanded in my Written Appearance, with Notice and Request, Dated: March 9, 2017. I was not given a lawful rebuttal and was not informed with the lawful written information that I had requested, and so by default my Notice and Claim stands as Fact and Evidence in Law on and for the Record; That You have been informed that, I, am a Natural Living Man, as a United States American with Natural and Constitutionally secured Rights and that I preserve and hold all of my lawful rights at all times, forever.

You were also informed that I am not the all capital NAME = Artificial Person =United States Corporate Citizen and STATE OF UTAH Corporate Citizen with no natural rights. You were informed of my lawful Name and lawful Address that you have dishonored and violated, continuing to pretend that I am the all capital NAME, or that I have agreed to be the Trustee or knowingly Contracted to be the Trustee; of which, I have never knowingly consented to be and I have never agreed to be such a thing.

Notice of the Facts with Lawful Claim for Damages

1. All Officers listed below that pulled me over were informed at that time, that I am not a Driver and that I am a Traveler and that I am a United States American, and am not a United States Corporate Citizen.
 - a. Utah Highway Patrol-man, Adam Gibbs on day 25 of February-2017: Citation: C150760510
 - b. Iron County Sheriff, Nik Johnson on day 11 of November-2018: Citation: I10155439
 - c. Washington County Sheriff, Erick Baron on day 29 of March-2019: Unlawful Arrest
2. The Citations of Adam Gibbs and Nik Johnson were signed: refusal for cause without dishonor; because they were using an incorrect and unlawful NAME and ADDRESS to falsely, incorrectly and unlawfully identify Me, the Living Spirit and Man; not being the all capital NAME and not being the trustee of the all capital NAME; not a United States Corporate Citizen and not a Driver; All being false, incorrect and unlawful Identification, of which Notice was given by Certified Mail on March 9, 2017, sent to Utah Governor Gary R. Herbert and Utah Attorney General Sean D. Reyes, and also sent to presiding Judge Margaret Miller, and Representing Attorney Shane A. Klenk for the STATE OF UTAH in Iron County Justice Court.
3. The Representing Attorney Shane A. Klenk for the STATE OF UTAH, did not send Me the Requested Information including any documented proof of Lawful inpersonam Jurisdiction related to the Accusation, did not give any lawful rebuttal to my Notice and so is in default of Accusation claim, and in violation of my Right to be informed of the Nature of the Accusation; as secured by Amendment VI. And Amendment IX. In the Bill of Rights.
4. Presiding Judge Margaret Miller did not uphold my Lawful Right to Due process of Law; to be informed of the Nature of the Accusation including the nature of any inpersonam Jurisdiction related to my real Lawful Identity, Nationality, and my Lawful Right to Travel. I do not know of any Lawful inpersonam Jurisdiction held by the Representatives of the STATE OF UTAH, and have not been given any documented proof of any such Lawful inpersonam Jurisdiction; if any exist in relation to my Right to Travel as a living man in Natural Constitutional Law, upholding my Right to Due Process of Law.

5. Presiding Judge Margaret Miller put out an unlawful Arrest Warrant in violation of; my Lawful information Identity, my Nationality, my Right to Due Process of Law, and my Right to Travel

On November 11, 2018; I was unlawfully arrested by Sheriff Nik Johnson and imprisoned for three days, and at such time, by a video Hearing on Accusations; I informed Judge Margaret Miller that I had not been given Lawful Due Process by the Judge and Representing Attorney for the STATE OF UTAH, also Margaret Miller admitted on video, that I have a Right to Make a written Appearance for a Hearing on Accusations. After Margaret Miller made excuses for not upholding my lawful Right to Due Process of Law by my written Special Appearance with Notice and Request to be Informed; then Margaret Miller set a Date for another Hearing on Accusations and I was released from Prison on November 13, 2018

So on December 3, 2018 before the Time of the Hearing, I hand delivered another written Special Appearance with Notice and Request to Be Information, that had more clarification than the previous Notice and Request; I hand delivered the Notice and Request to the Lady at the Attorneys Office and to the Clerk of the Court, and I informed the Clerk of the Court that I was not qualified to appear in person without first being Informed of the Nature of the Accusation and because I did not have qualified assistance of Counsel for Defense of my Rights. After I delivered my written Special Appearance with Notice and Request to Be Informed, I was not given any written information or any rebuttal to my Notice and Request, in a lawful Time-frame, and so by Default, my Notice stands as Fact and Evidence in Law on and for the Record, and upon this Evidence and Fact of Default by the Attorney for the STATE OF UTAH; I demand that this Court dismiss all Accusations and Claims upon Me by the Representing Attorney Marcus L. Gilson; for lack of lawful Inpersonam Jurisdiction and for not providing any lawful proof for Accusation claim upon Me. And by these presents, I give you:

Notice of Lawful Claim for Damages

1. Because of an unlawful warrant by Judge Margaret Miller violating my Right to Lawful Due Process, Sheriff Erik Baron, on March 29, 2019; unlawfully arrested Me violating my Lawful Identity, and my Lawful Nationality; after I informed Him that I am a Traveler and not a Driver, and that I am a United States American, and not a United States Corporate Citizen; He continued to pretend that I was the Artificial Person with the all capital NAME or the Trustee of the all capital NAME and using unlawful Identification, He continued to arrest Me and unlawfully make false Accusations upon Me, such as Driving without a License. The Officers at the Prison were also informed by Me that I am a United States American and not a United States Corporate Citizen, and They also continued to use false and unlawful Identification.
2. While in unlawful Imprisonment for Ten days in Washington County, and at all Video Hearings in Prison, I informed the Washington County Judge and Judge Margaret Miller of my lawful Identity and my Right to Lawful Due Process, that They continued to Violate. After Ten days of unlawful imprisonment Officers hauled Me to Iron County Prison were I was unlawfully imprisoned for another Fourteen days, with my Lawful Identity and my Lawful Right to Due Process, being violated by Judge, Attorney and Officers.
3. As a result of the STATE OF UTAH, IRON COUNTY, Attorney Shane A. Klenk, Attorney Marcus L. Gilson, and Judge Margaret Miller violating my Lawful Identity, my Nationality, and my Right to Lawful Due Process as a United States American with Natural and Constitutionally enforced Rights by Lawful Oath of Allegiance.

Because Notice has been given to You of the Damages caused upon Me, by conspiracy and violation upon Me, violating my Identity, my Nationality, and my Right to Lawful Due Process, and in conspiracy being disguised as Lawful Public Servants for the United States of America, violating my Natural and Constitutionally enforced Rights; And by these presents, I give you:

Notice of Noncontradictory Definitions of Rights, Law, and Justice:

Rights are not a manmade invention.
